JOB TITLE: CarePartner (In-Home)

DEPARTMENT: Redwood Coast PACE

REPORTS TO: Home Care Manager

FLSA STATUS: Non-Exempt/Hourly

<u>JOB SUMMARY:</u> Under the supervision of the Home Care Manager, provides home care services to Redwood Coast PACE participants in their homes as authorized in the participant's Plan of Care as determined by the Interdisciplinary Team.

ESSENTIAL DUTIES AND RESONSIBILITIES:

- 1. Assists participants with bathing, grooming, toileting, and feeding at home.
- 2. As applicable and per the program participant's Plan of Care:
 - a. Provides escort services to and from participant medical and other appointments.
 - b. Routinely monitors vital signs such as weight, temperature, blood pressure, and pulse at home.
 - c. Maintains personal care supplies such as incontinence supplies, nutritional supplements, and personal grooming items.
 - d. Provides laundry services at home.
 - e. Provides light shopping for necessary items such as toiletries, breakfast, and snack items.
 - f. Provides light housekeeping to maintain a clean and sanitary environment in the home.
 - g. Prepares diet appropriate meals for participants who require assistance at home.
 - h. Provides nutritional supplements to participants at home as ordered by the Primary Care Provider and directed by the Registered Dietitian.
 - i. Assists in the monitoring of appropriate diet and food and fluid intake in the home.
 - j. Monitors that frozen meals are sent home with participants, as required.
 - k. Implements the Physical Therapy and Occupational Therapy maintenance programs in the home.
 - I. Assists in the monitoring of participant physical and chemical restraints, adhering to policy and procedures for monitoring and communicating with Primary Care Physician, Registered Nurse (RN), and/or Home Care Manager as required.
- 3. Assists participants in the home to get ready for transportation to the Day Center in the morning.

- 4. Immediately reports any observed changes in a participant's behavior, health or mobility to the Home Care Manager, Registered Nurse (RN), and other disciplines as needed.
- 5. Participates on the Interdisciplinary Team as required and communicates effectively with participants, family members, caregivers, and employees.
- 6. Completes documentation in the medical record accurately and in a timely manner.
- 7. Complies with safety policies and procedures, identifying and immediately reporting any potential or actual unsafe acts or conditions per the policies and procedures. Takes necessary measures to ensure a safety environment for oneself, co-workers, contractors, participants, visitors and others.
- 8. Monitors personal safety and attends to good body mechanics. Ensures infection and exposure control and is prepared in case of emergency.
- 9. Consistently meets or exceeds Redwood Coast PACE targets for productivity.
- 10. Consistently meets or exceeds Redwood Coast PACE targets for customer service.
- 11. Continually seeks better ways for delivering services and communicating with participants.
- 12. Effectively collaborates with co-workers and contractors to meet Redwood Coast PACE goals and further success of the program.
- 13. Complies with all policy and procedures of Redwood Coast PACE.
- 14. Demonstrates proficiency in delivering age-specific care.
- 15. Participates in the process of teaching, training, and mentoring student interns and volunteers working within the program area.
- 16. Other duties as assigned.

EDUCATION &/or EXPERIENCE:

- 1. Must have a high school diploma or GED equivalent.
- 2. Must have at least one (1) year of experience working with a frail or elderly population, preferably providing personal care in a health facility or in-home setting.

LICENSES OR CERTIFICATES:

- 1. Current CPR and First Aid certification within six (6) months of hire.
- Valid California Driver's License, good driving record, and personal auto liability insurance required. Must have a personal vehicle in good driving/operating condition, insured for State minimum liability requirements, and that can be used for the applicable job functions noted above.
- 3. Certified Nursing Assistant or Certified Home Health Aide is preferred.

PRE-SCREENING REQUIREMENTS:

1. Requires clearance of a DOJ and FBI criminal history background check, pre-employment DOT physical, and PPD skin test (TB screening).

JOB SKILLS:

1. Demonstrates respect for and promotes participant rights, including dignity, self-determination, access to care, confidentiality, and independence.

- 2. Understands the importance of community involvement and participates as appropriate in activities that link Redwood Coast PACE to the community.
- 3. Ability to provide care for frail elderly. Teamwork and problem solving skills. Excellent interpersonal interactions that result in team building.
- 4. Ability to complete duties within an agreed upon time frame and to adjust personal schedule if required.
- 5. Ability to adapt appropriately to change of priorities and workload.
- 6. Ability to maintain a consistent level of productivity.
- 7. Sound verbal communication skills to convey information effectively and listening skills to receive directions and understand participant concerns.
- 8. Ability to maintain a positive attitude and balance in relationships with others. Exhibits patience and compassion in work with participants.
- 9. Ability to understand detailed requirements in working activities.
